# **SCMA Briefing Sheet**

## **Becoming an Elected Member**

Scottish Childminding Association (SCMA) has developed this range of briefing sheets in response to the main questions we receive through our Helpline (01786 449063) which is open Monday to Friday, 10 am to 4 pm. This briefing sheet aims to provide you with everything you need to know about becoming an Elected Member for SCMA.

#### SCMA's Vision Statement:

"Quality childminding...building confident children within a family childcare experience."

SCMA is the only organisation in Scotland dedicated to supporting, guiding and helping childminders to provide the best childcare services they possibly can. The Association's main aim is to build confident children within a family childcare experience through supported, fully-trained childminders. In order to provide our members with a 'voice for childminding' we invite nominations for Elected Members each year.

When elected, the Elected Member will ensure their local authority area is represented in SCMA decisions. In doing this, Elected Members help SCMA to keep up-to-date with issues in childminding which we can then feedback to the Care Inspectorate and local and central Government.

#### The Association

The Association is both a registered charity and a Company Limited by Guarantee managed by the Scottish Executive Board; the majority of board members are working childminders. The Association employs a growing number of staff to develop childminding. SCMA is responsible for supporting and promoting childminding in Scotland.

#### The Role of the Elected Member

Each year, many volunteers take on the role of Elected Member and the responsibilities of being a local 'voice for childminding'. Elected Members hold positions of trust and must ensure:

- confidentially until SCMA decisions are ready to share.
- they are good role models for SCMA.
- they read the relevant papers.
- keep in touch with local developments.
- raise the profile of Childminding and the work of the Association locally.
- they direct the Association's policies and strategic plan.

A unique strength of SCMA is that it is managed by people who freely donate their time, ideas and energy to support both the Scottish Executive Board (SEB) and the Childminding Development Team (CDT).

Once elected you need to select the team you wish to be a part of, either the SEB or the CDT, with a final decision being made about which team you join at the first Elected members meeting. All out-of-pocket expenses incurred by Elected Members will be reimbursed by SCMA.



### Responsibilities of a SEB member:

- Monitor and evaluate the Strategic Plan
- Monitor Income and Expenditure
- Decide membership fees
- Review the Annual Accounts
- Agree the pay structure and other employee benefits
- Review the Constitutional structure
- Comment and agree on Constitutions and Standing Orders
- Appoint working parties and/or groups
- Appoint the Chief Executive

#### Responsibilities of a CDT member;

Act as a focus group for the development of:

- · Marketing strategies and training
- Publications and promotional items
- The website and magazine
- Policies for providing support to childminders

Each Elected Member has knowledge and practical experience of childminding. It is this combination that has helped SCMA towards the professional status it holds today. Elected Members are usually voted into office at the AGM for a maximum of six years. For more information about this process please contact the Chief Executive at Head Office on **01786 445377**.
